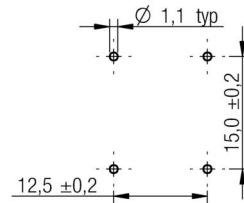

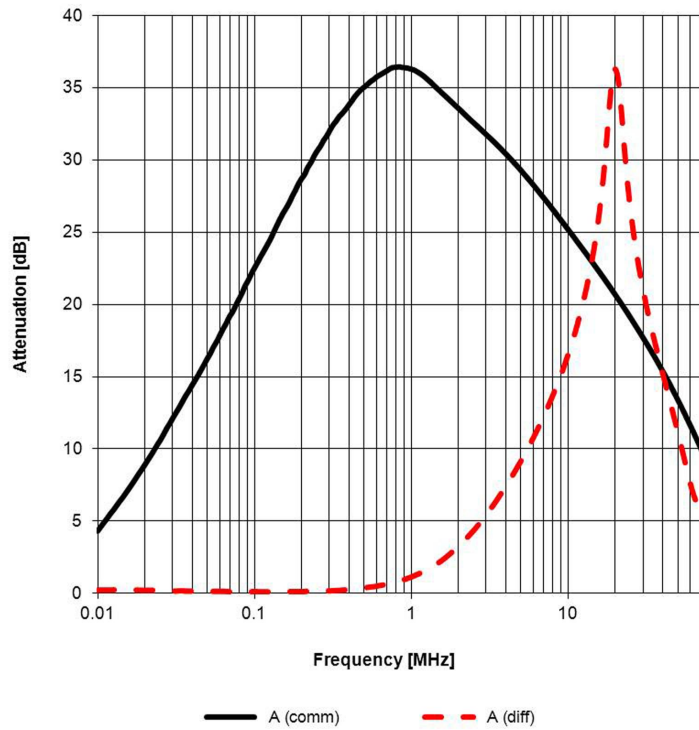



Product specific:


